Meeting Called to Order

Approval of Minutes

February 10, 2020 meeting minutes were reviewed. Mr. Miller made motion to approve minutes as written, seconded by Mr. Porter. All in favor. Minutes approved as written.

New Business

The Opportunity Zone: Mayor Garlich is given the floor and is present to discuss The Ohio Opportunity Zone Tax Credit Program. The local Zone is a stretch of land from Burton-Windsor to Shedd, all the way to Trumbull County. The new rule permits 10 years to invest if there is a tax liability. There is a seminar on March 19 and the Mayor invites all interested to attend and to extend the invitations to potential interested parties including Amish community. <u>Fire Dept.</u> The Mayor also shared that he met with auditor regarding the Fund and thinks it looks pretty good but it should continue to be reviewed in light of their carryover for salary/payroll. He reminded that the Fire Department is not a Village entity.
